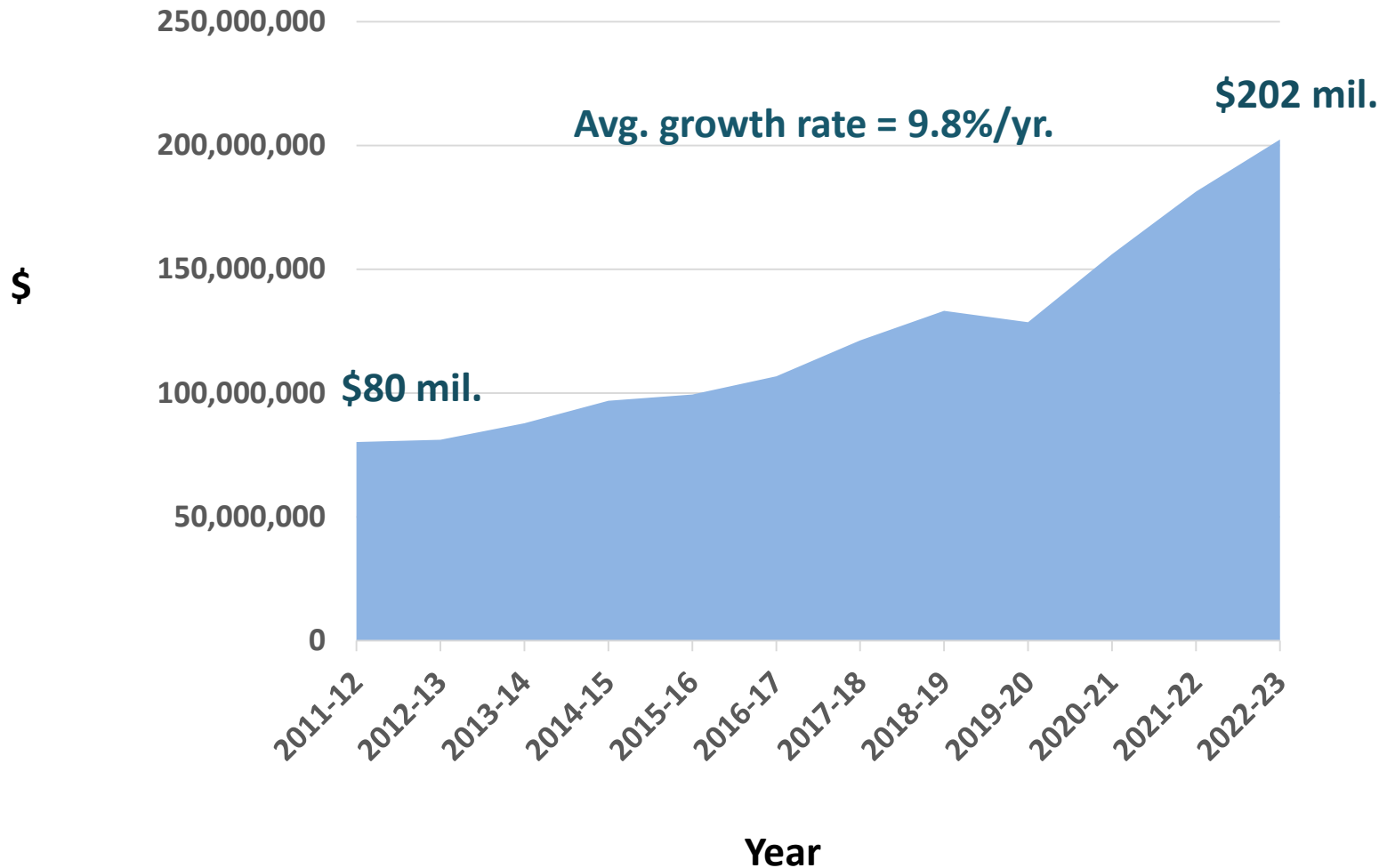

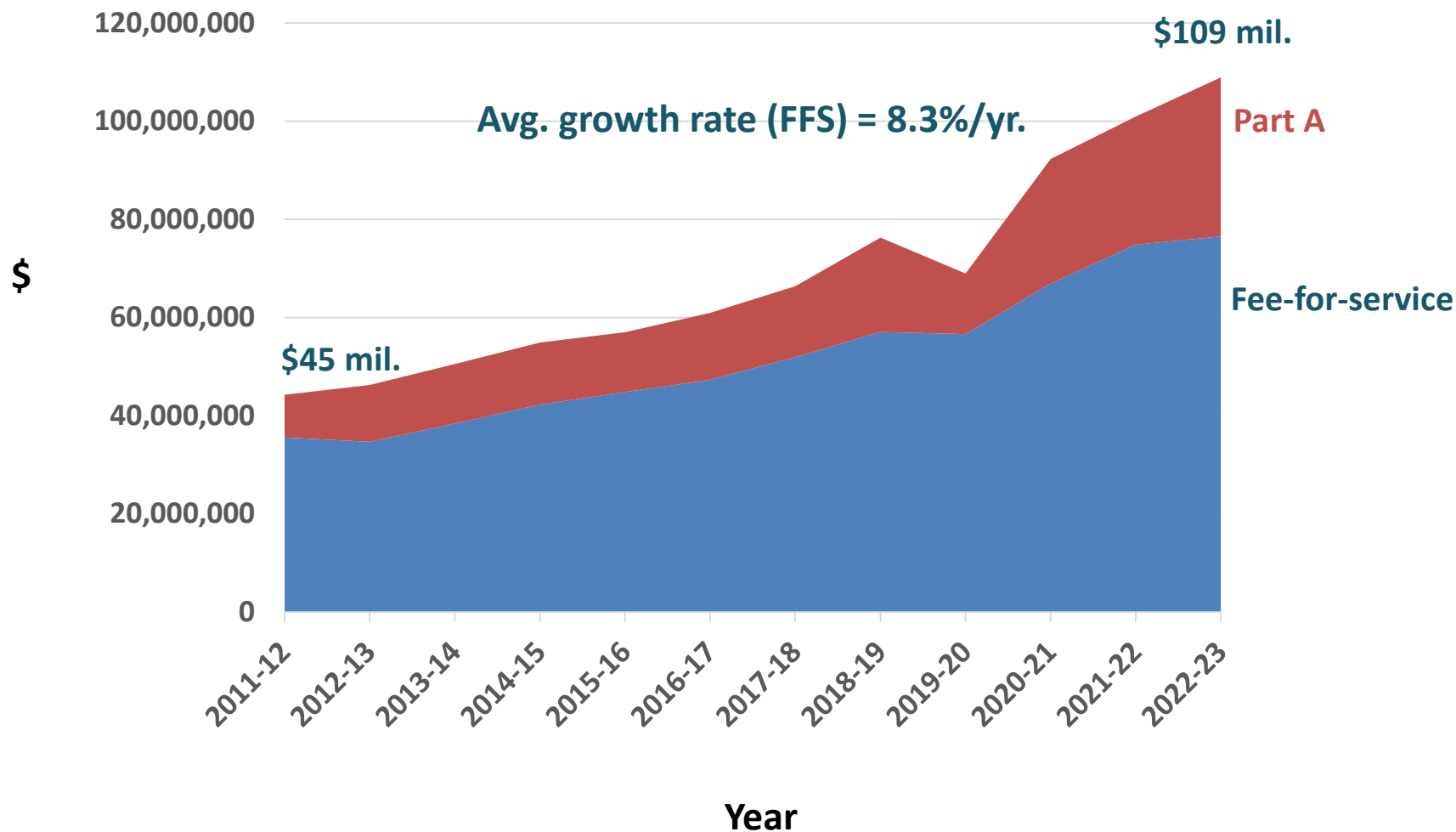


DoM Charge Trend (Faculty Practice)

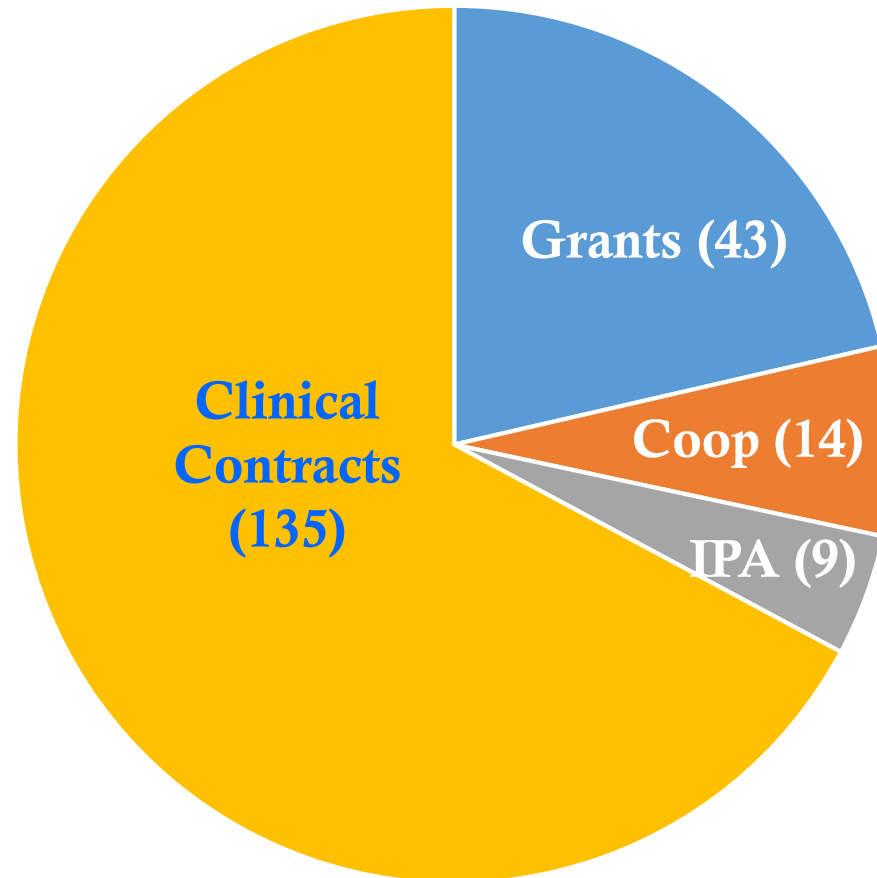

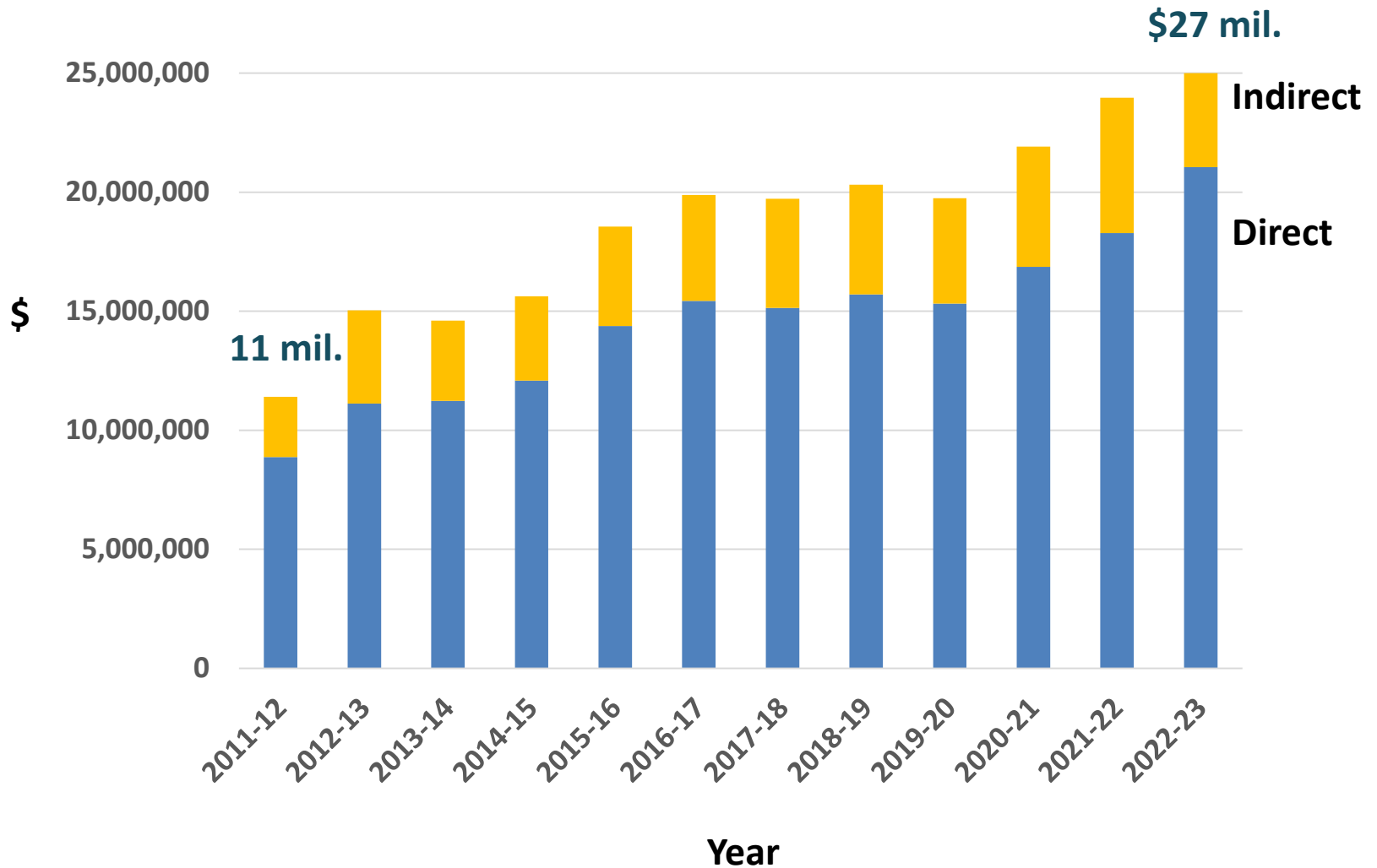

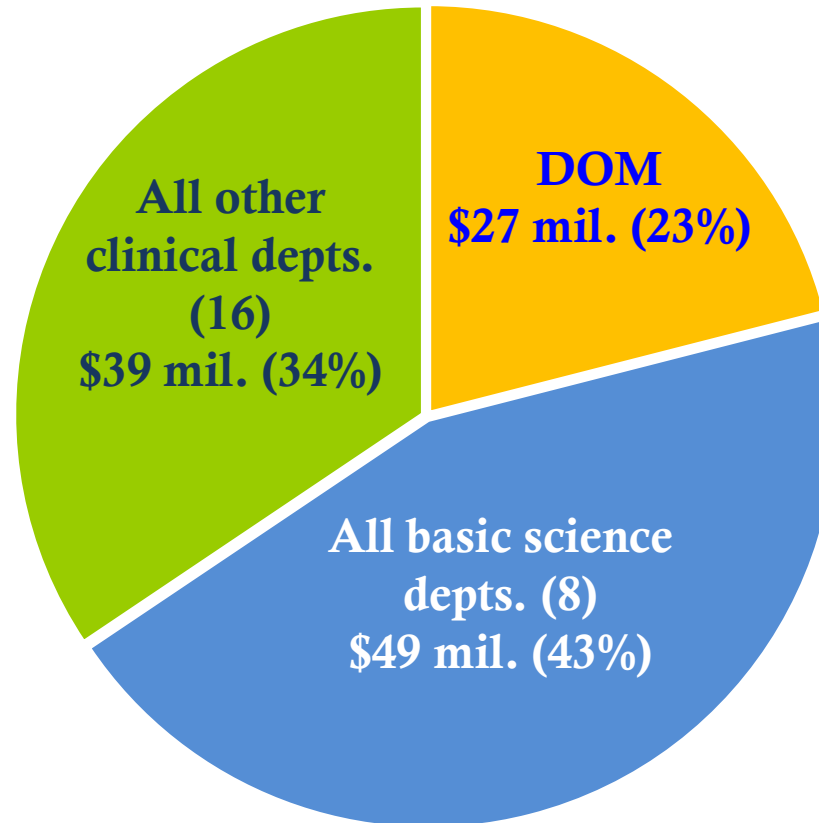




DoM Research Expenditures - Trend

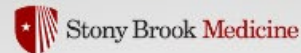


DoM Research Expenditures – Share of RSOM
