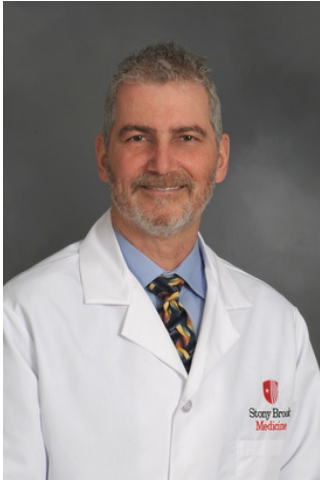

## MESSAGE FROM THE VICE CHAIRMAN

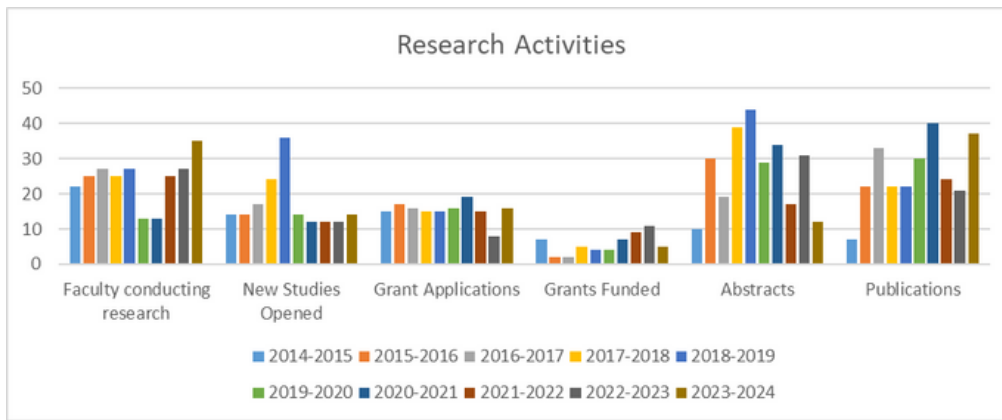

I have had the privilege of serving as the Vice Chairman for Research since I was appointed to this position by Dr. Todd Griffin in 2014. On December 31, 2024, I will step down and turn over leadership of our department's research program to Dr. Cassandra Heiselman. Dr. Heiselman has served as the Assistant Vice Chair for Research this year. She is an accomplished researcher who is highly respected by her peers within and outside our department.

As I wrote in my first Vice Chairman's Report in 2014, "Since its inception, the Department of Obstetrics, Gynecology and Reproductive Medicine at Stony Brook University has been committed to creating and expanding knowledge of women's health through basic and clinical research. During that time, the research conducted by the faculty, fellows, residents and medical students has altered the practice of medicine in the United States.

In 2010, Dr. Gerry Quirk consolidated the research activities of the Department into a research division and appointed Dr. David Baker as the initial director. Under Dr. Baker's leadership until he stepped down in 2014, the division supported those faculty, fellows and residents who were involved in research activities and assisted new faculty with developing their research projects. Dr. Quirk and Dr. Baker deserve tremendous credit for their leadership in support of the research mission of the Department."

I am, justifiably I believe, extremely proud of the Research Division's accomplishments over the past decade. It takes a team; our team is extraordinary and I am grateful to each and every one of them. In this, my final annual report as the Vice Chair for Research, I have summarized our accomplishments.

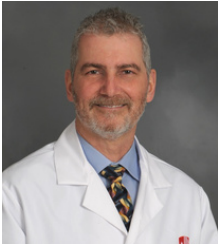
# MISSION

### **Michael Pearl, MD | Vice-Chair for Research and Faculty Development**

Dr. Michael Pearl is a Professor, Division of Gynecological Oncology; the Vice Chairman, ObGyn Research and Faculty Development; the Director of Women's Cancer Services, Cancer Center and the Medical Director, Cancer Center Clinical Trials Office. He is the Principal Investigator at Stony Brook Medicine for NRG Oncology, a National Cancer Institute-funded cooperative research group dedicated to promoting excellence in the quality and integrity of scientific research. As Vice-Chair, Dr. Pearl oversees departmental research projects and advises faculty and staff on related matters.



### **Cassandra Heiselman, DO, MPH | Assistant Vice-Chair of Research, Assistant Professor Department of Obstetrics, Gynecology and Reproductive Medicine**

Dr. Cassandra Heiselman is an Assistant Professor at Stony Brook Medicine (NY), where she also completed MFM fellowship. Her schooling includes Boston University (BA with distinction), Tulane's School of Public Health (MPH/Delta Omega Honorary Society), and Kansas City University of Medicine and Biosciences (DO). She completed OB/GYN residency at Cleveland Clinic Akron General and her fellowship at Stony Brook Medicine. Her research interests include fetal heart rate signal processing and machine learning; stress, stigma, social determinants of health and perinatal experiences and outcomes; syphilis in pregnancy; opioid use disorder in pregnancy; birth satisfaction; hypertensive disorder of pregnancy; and maternal mental health. As a committed women's health care physician, her aim is to provide holistic, in-depth medical treatment focusing on personalized care for the unique needs of both mother and baby through an evidence-based, multidisciplinary approach. She also acts as Assistant Program Director for Global Women's Health Fellowship and the Co-Medical Director of the Coordinated Fetal Care Program at Stony Brook University Hospital.



### **Elizabeth Roemer, MA | Associate Director of Research**

Elizabeth Roemer is the primary point-of-contact between the Division of Research and the SUNY Research Foundation offices and the Stony Brook Office of Vice President for Research. She facilitates interaction with academic departments on and off campus and aids faculty and residents in developing their research interests. In addition, Ms. Roemer identifies and tracks funding opportunities and works with faculty to develop strategies and proposals for grant and clinical research funding. She is the Division's key resource to obtain auxiliary services and assistance for research enterprises.



**Heidi Preis, MSW, PhD | Senior Research Scientist, Associate Professor of Research, Department of Obstetrics, Gynecology and Reproductive Medicine, Affiliated with the Department of Psychology and Program in Public Health**

Dr. Heidi Preis received her PhD in Social Work in 2018 and conducted a postdoctoral fellowship in the departments of Psychology and Pediatrics at Stony Brook University. For the past several years she has taught Biostatistics in the Program in Public Health and has authored over 50 peer-reviewed articles. Dr. Preis is the PI of two ongoing federally and institutionally funded projects-- The SB-COPE Study which follows a large national cohort of mothers who were pregnant during the COVID-19 pandemic and the PROMOTE project to improve screening for psychosocial vulnerabilities and substance use in prenatal care. Most recently she launched the PROPIT Study investigating obstetric providers' perspectives regarding induction of labor and trial of labor after cesarean.

**Marci Lobel, PhD | Director, Stress and Reproduction (STAR) Lab, Distinguished Professor, Department of Psychology and Department of Obstetrics, Gynecology and Reproductive Medicine**

Marci Lobel, Ph.D. holds a primary appointment as Professor of Psychology. She is Director of the Stony Brook Stress and Reproduction (STAR) Lab which focuses on perinatal stress, coping, and health behaviors that affect maternal and child health. She collaborates with colleagues in the US and Europe, is an author of more than 300 articles and conference presentations, and is the recipient of national and university awards for her research, service, teaching, and mentorship. She directs the International COVID-19 Pregnancy Experiences (I-COPE) Study and is Co-Investigator of a project to develop the Profile for Maternal & Obstetric Treatment Effectiveness (PROMOTE) prenatal vulnerability screening tool.



**James E. Swain, MD, PhD, FRCPC | Associate Professor of Psychiatry, Behavioral Health and Psychology**

Dr. Swain is cross appointed to Obstetrics, Gynecology & Reproductive Medicine at Stony Brook Medicine, where he serves as perinatal mental health consultant to maternal fetal medicine. He is Principal Investigator of National Institutes of Health research projects on Maternal Brain-Behavior Adaptations and Interventions in the Early Postpartum. Currently a fellow member of the American College of Neuropsychopharmacology, Dr. Swain has authored over one hundred peer-reviewed articles and book chapters on the neuroscience of parenting, stress, and development.
