Nazia Sarker, MD, MPH Geriatric Fellow: Does moving high- risk fall patients to a special care unit with trained staff to provide support for ambulation, hydration and closer monitoring, result in a decreased rate of falls among older adults in a long-term care facility?

Anshu Singh, MD, Medical Director LISVH: Will a one-year structured behavioral health training program equip direct care staff with the tools to manage disturbing behaviors in nursing home residents and de-escalate challenging situations? Will such training improve staff satisfaction and retention? Will it impact quality indicators for the facility?
