## Mandatory Professional Licensure Disclosure

New York State prides itself in the high quality of its licensed and certified professionals. For the protection of its citizens, each license and certificate has requirements that individuals must meet in order to be licensed or certified in New York State. The State University of New York's (SUNY's) academic programs leading to licensure or certification are carefully designed to meet and exceed these State requirements. Thus, SUNY plays a significant role in protecting the public. Other states frequently have their own licensure or certification requirements; if your goal is to practice in another state, this professional licensure disclosure will help you to determine that state's licensure or certification requirements.

Per U.S. Federal Regulations, §668.43 (2019 Rule), and in compliance with the National Council for State Authorization Reciprocity Agreements' *State Authorization Reciprocity Agreements (SARA) Manual version 19.2*, the SUNY Renaissance School of Medicine at Stony Brook University provides the following disclosure related to the educational requirements for professional licensure and certification.<sup>1</sup>

This Disclosure is strictly limited to the SUNY Renaissance School of Medicine at Stony Brook University's determination of whether its educational program – specifically, the MD degree program – that, if successfully completed, would be sufficient to meet the educational licensure or certification requirements in a state for the practice of medicine.<sup>2</sup> The SUNY Renaissance School of Medicine at Stony Brook University cannot provide verification of an individual's ability to meet licensure or certification requirements unrelated to its educational programming. Such individual determinations are made by state licensing boards, and are fact-specific determinations.

This disclosure does not provide any guarantee that any particular state licensure or certification entity will approve or deny your application. Furthermore, this disclosure does not account for changes in state law or regulations that may affect your application for licensure and that occur after this disclosure has been made. Enrolled students and prospective students are strongly encouraged to contact a state's licensure entity using the links provided to review that state's licensure and certification requirements.
